Late Proposal to IGC Plenum 2020 (by IGC) Subjective rules in Annex A.

The events of recent championships has prompted the IGC bureau to review the current rules in Annex A regarding sanctions and penalties for none technical offences. This proposal is intended to add clarity and guidance to support the officials at IGC events. The proposal includes the addition of a definition and penalties for cheating and clarity on applicable periods for offences of unsporting behaviour.

This proposal affects four relevant sections of Sporting Code Annex 3a

- 1. 8.6.5 Unsporting Behaviour,
- 2. 8.6.6 and
- 3. 8.7 List of Approved Penalties
- 4. 5.4.2 Control procedures

Additions or changes to existing rules are underlined text.

Current 8.6.5

8.6.5 Unsporting Behaviour

- a. Championship pilots and team members who demonstrate aggressive and abusive behaviour to championships Organisers and/or FAI/IGC officials will be sanctioned for unsporting behaviour.
- b. The Championship Director will issue a penalty for unsporting behaviour, the size of the penalty dependent on the level of aggression and/or abuse demonstrated. The penalty imposed may be a warning, issuing of championship penalty points, day disqualification or event disqualification.
- c. Other team members (Team Captains, crew and other members) who demonstrate unsporting behaviour may incur a penalty ranging from being required to make a public apology to removal from the event.
- d. Very serious examples will be referred to the NAC involved and/or IGC/FAI.

Proposed 8.6.5.

8.6.5 Cheating and Unsporting Behaviour

a. Cheating.

 A premeditated and deliberate attempt by a pilot, crew or team to circumvent the rules or local procedures in order to gain a competitive advantage is considered to be cheating.

<u>2. Any pilot, team member or team found to be cheating will be disqualified from the competition.</u>

b. <mark>Unsporting Behaviour</mark>.

1. Pilots.

<u>a. Dangerous or hazardous flying,</u>

b. Flying under the influence of alcohol or banned and/or controlled substances,
c. A positive result on a doping control,

d. Aggressive and abusive actions (verbal or physical), toward Championships Organisers, volunteers or FAI/IGC officials.

2. <u>Team Members</u>.

a. Aggressive and abusive actions (verbal or physical), toward Championships Organisers, volunteers or FAI/IGC officials. The Championship Director may issue a penalty for unsporting behaviour as follows,

a. <u>Pilots</u>. The penalty imposed for pilots may be a warning, issuing of competition penalty points, day disqualification or event disqualification.

b. <u>Team Members.</u> Other team members (Team Captains, crew and other members) may incur a penalty ranging from being required to make a public apology to removal from the event.

<u>c. Other.</u>

 All serious instances of cheating or unsportsmanlike behaviour will be referred to the IGC/FAI and the NAC involved. FAI/IGC may issue a ban on Pilots or teams from participating competing in future championships.

Current 8.6.6 Penalties in the following categories:

- Unsporting behaviour
- Dangerous or hazardous flying and the following specific penalties:
- Flying under the influence of alcohol
- Positive doping control

shall be included in the competitor's overall contest results (including the competitor's cumulative Score), even if imposed during the training period or on a day which does not meet the requirements of a Championship Day (8.2.1).

a. Dangerous or hazardous flying

b. Aggressive and abusive actions (verbal or physical), toward Championships

Organisers, volunteers or FAI/IGC officials

Shall be included in the competitor's overall contest results (including the competitor's cumulative Score), even if imposed during the training period or on a day which does not meet the requirements of a Championship Day (8.2.1).
