After receiving all the Judges' applications by the JC, the selection was made according to the following process:



- Stage 1: Selection by means of a "Selected" or "Not Selected" for each application by 6 Members of the JC. With 4 times "Not Selected", the application was rejected;
- Stage 2: Each Member of the JC had to select the Judges for each group.

The final decision on the selection was sent to the Delegates or Judges (if a given email address was known).

- Stage 3: Later adaptations (withdrawals, etc.).

3 - SCHEDULE OF SELECTION PROCESS

An invitation to deliver an application was sent by email the 22nd December 2022, with a deadline for the 14th January 2023

The received applications were compiled on a working table and could be consulted by all the members of the JC.

STAGE 1

Stage 1 began in mid-January 2023, with the presence of 6 members of the JC.

STAGE 2

Stage 2 started at the end of January 2023 with amendments to the previous applications in order to find capable assistants for some Judges.

Stage 2 ended on 5 March 2023.

- The shortage of judges in some groups (based on the JRP) resulted in certain adaptations.

STAGE 3

Constant changes required 2 versions of the final document Selection of Judges:

- Change of assistants;
- Unavailable judges;
- Withdrawals.

4 - DURING THE COMPETITIONS

No adaptations were necessary during competitions

5 - SUMMARY 2023

All the panels of Judges were completed successfully:

- SKY GP: 1 judge

EIAC+: 4 Judges >> Competition canceled

EAC: 7 Judges

- WGAC/WAGAC: 7 Judges

WAAC: 7 Judges + 1 additional judge (USA)



6 - RECOMMENDATIONS

JC's proposals: General situation

The JC do not have the capacity to make proposals for rule changes directly, or proposals for rewriting some articles of the rules for clarification.

OBSERVATIONS IN SITU - EX PZs BECOMING HZs

The Chairman of the JC, on site for EAC, WAGAC/WGAC and WAAC has observed a huge loss of time in the conduct of competitions, due to long video reviews for HZ connected with flicks and spins

JC's recommendation for PZs replaced in 2022 by HZs

- Improper flick for pitch / yaw, etc: up to minus 4 or 5 points
- Improper spin entries: up to minus 4 or 5 points
- Tail slides not sliding: minus 4
- Flick in rolling circles: HZ
- Exit on axis: minus 1 point / 5° on axis
