

CIA Jury Board meeting 2020

Minutes video meetings 13 March 1400-1600 and March 25 1100-1220

Taking part: Hans Åkerstedt, JC Weber, Les Purfield and Hiropon Soejima

1. Minutes 2019 JB meeting examined. No comments
2. Selection of event juries for 2020 and 2021 events
Juries for 4th Women Worlds, Poland and for 24th AX worlds, Murska Sobota were approved 2019
Post LBT, Luxembourg, 64th Gordon Bennett, POL and Szeged Cup, Hungary.
No jurors were nominated by organisers. The JB decided to use the JB procedure.
See attachment **JB 2020-01**. All jurors contacted and have accepted. Need to appoint one juror to be on site as proposed jury chairman must stay at home (Virus problem in family)
3. **Luc van Geyte, BEL**. The Jury Board recommend upgrading to intermediate. Test is approved and a new application form with updated CV data has been received.
The Jury Board recommend that **Martine Besnainou, FRA**, is removed from the list of jurors. Despite several efforts to contact her, she failed to appear for jury meeting at Gordon Bennett 2019. A replacement juror was appointed as a replacement for remote work.
4. Jury reports from events 2019. The performance bond has been released for all events. The Jury Board will ask the CIA Bureau to request amendments to OA re CIA protocol and the creating, updating and maintaining of an event website. See attachment **JB 2020-02**.
Jean Claude will examine the reports to see if any further action is needed
5. Recommendations from the 2019 GB jury have been sent on to the Statutes subcommittee and the AA subcommittee. (Definition of landing and distance calculation method)
6. The FAI Statutes have been changed. Issue 2020 is in effect. A document with all changes was examined, and is attached (**JB 2020-03**). No significant changes affecting CIA found.
7. JHB updates. Updates decided in 2019 are incorporated in JHB version 18/2019. Further updates will be included in version 19 after the JB meeting 2020
8. Garry Lockyer has resigned as on-line test manager for Test 1 and 2. Test for senior level is still on paper only. We may revert to old tests unless someone can take over on-line testing management.
9. Jury selection procedure. JB decided to propose a simplified method.
Proposal from 2019 modified. New proposal to CIA Bureau for approval. See **JB 2020-04**
Jury procedure for Gordon Bennett events. New proposal to include suggestion from AA Subcommittee and to include video protest hearing. Proposed for approval. See **JB 2020-05**.
10. The following delegated responsibilities were proposed and accepted.
Jean Claude: Jury report handling
Les Purfield: Event jury selection
Hiropon Soejima: Jury application management
11. After the resignation of Sandor Hidas, one more member to the JB is needed. John Grubbström proposed and has accepted.
