REQUEST EUROPEAN CHAMPIONSHIP 2021 ORGANISATION

The bureau received 2 requests for changes to the sanction application for the European Championship and has decided the following.

Request 1:

Your request was:

We would like to extend the competitors number of Europeans 2021 to 100+5 pilots. We ready to pay the different of sanction fee immediately when we receive the invoice.

Bureau decision:

The bureau decided not to accept your request. We think that under the current COVID situation it is unlikely that 2021 events will have full partipation.

The following factors influenced this decision: The current field of 80+4 is sufficient to ensure that the best pilots from each European country can attend, safety concerns with a larger event, and maintain a high quality event with the uncertainty of the covid situation."

Request 2

You requested to change the deadlines for the invitation procedure, the following.

Start to send out the invitation to NACs at 15th January

Deadline for NACs to send nominations is 10th February.

Individual Invitation to Competitors will be sent on 15th February.

1st round deadline for competitors application and entry fee is 10th March.

2nd round start 15th of March.

2nd round deadline for Competitors application and entry fee 09th April.

Bureau decision and response:

The bureau does not accept this change, due to the current COVID situation we would like to propose the following adjustment.

Start to send out the invitation to NACs at 15th January

Deadline for NACs to send nominations is 28th February.

Individual Invitation to Competitors will be sent on 1st March.

1st round deadline for competitors application and entry fee is 30th April.

2nd round start 1st of May.

2nd round deadline for Competitors application and entry fee 31st of May.

We believe this gives pilots time to see how the pandemic situation develops and allows them enough time to decide whether they want to participate or not. We hope you can agree with this timeline.
