#### PROPOSAL TO IGC PLENARY 2006

### **Proposed by IGC Bureau**

## It is Proposed That:

For events in 2007 and following years, Sanction Fees be set at two levels for IGC sanctioned events:

(a) A baseline Sanction Fee of:

€ 200 EURO for the Sailplane Grand Prix (SGP)

€ 1,000 EURO for the Barron Hilton

€ 1,500 EURO for the European GC, WGC

- (b) An "Officials" Sanction Fee of € 75 per pilot for the European GC and WGC
- (c) Except that no Sanction Fee shall be applied to the Juniors WGC

The Officials Sanction Fee shall be used to allow the IGC to fund the positions of Jury President and Chief Steward to support transport, accommodation and meal costs.

The costs for Jury Members and other Stewards shall remain the responsibility of the Organisers.

# **Reasons supporting the Proposal:**

In 2005 the following Year One proposal were accepted unanimously:

- SC3, Annex A, Para 1.4.5: National Aero Clubs will pay sanction fees to IGC on a per entry basis for all Category 1 and 2 events sanctioned by IGC.
- SC 3, Annex A, Para 1.4.6: The travel and living expenses for the International Officials at a Category 1 or 2 IGC sanctioned event (Jury, Referee and Stewards) are the responsibility of IGC and paid by the sanction fees.

The Bureau has subsequently modelled a number of scenarios. The Bureau has also agreed that considerable time and effort could be expended in arranging travel and accommodation for Jury members and Stewards.

The conclusion of the Bureau is that the best option is for costs of the Jury President (JP) and the Chief Steward (CS), and the Referee for the Sailplane Grand Prix, being independent of the Organisers.

The costs of supporting the JP and the CS are shown in Table 1. below.

#### **Travel assumptions**

- 1. Airfare/travel allowance of 250 Euro/ trip to the site as base cost for Europeans and European competitions; Travel from outside of Europe will be on a case-by-case basis reimbursement of minimal airfares
- 2. Chief Steward travel cost based on two trips to site 1 trip for site inspection and planning with organizers and 1 trip for competition

#### **Accommodation assumptions**

- 1. Room cost estimated to be 50 Euro per day
- 2. Jury President estimated to be in attendance for 16 days
- 3. Chief Steward on site for 22 days (2 days for pre-contest inspection trip + 20 days for contest)

#### **Vehicle assumptions**

- 1. On-site Jury President and Chief Steward will share vehicle for the period
- 2. Vehicle rented for 20 days
- 3. Chief Steward to have vehicle + fuel for 2 day inspection trip
- 4. Fuel for period estimated to be 400 Euro

#### **Food assumptions**

- 1. Meal allowance of 20 Euro per day
- 2. Jury President estimated to be in attendance for 16 days
- 3. Chief Steward on site for 22 days (2 days for pre-contest inspection trip + 20 days for contest)

#### Miscellaneous assumptions

1. Allowance of 5 Euro/day for miscellaneous expense

The past annual budgets for the IGC are shown in Table 2.

Table 3 models the effect of the Sanction Fees and Officials Sanction Fee.

The Official Sanction Fee is established at € 75. At this value the Officials Sanction Fee does not cover all the expenses for JP, CS and Referee.

In particular the costs for supporting the JP and CS at the Juniors and the Referee at the SGP come from cross-subsidies from the baseline Sanction Fees.

Note also that no IGC Officials are involved with the Barron Hilton.
