

## Year 2 Proposal

The Sporting Code Committee introduced this proposal at the last meeting, the intention being to ensure that Free Distance records when done in the same flight as a declared distance record are in fact *“a significant and highly praiseworthy accomplishment requiring unusual effort and skill from the pilot”*. In practice, what is occurring now with a large percentage of Free Distance records fails to meet that definition of superior effort. We offered two options, the first to only allow one distance claim per flight, and the second, if a free distance record is to be claimed in conjunction with a declared distance record, it must exceed the declared distance by at least 10%. This second option was chosen by the plenary to go forward for further consideration and presentation to this meeting.

The committee has considered the proposal closely, and has come to the conclusion that the 10% figure is too high and should be reduced to 5% with a maximum requirement of at least 25 kilometres more than the declared record claim.

Bear in mind that this formula does NOT apply if the pilot chooses to claim the Free Record and NOT the declared Record; in this case, the pilot need only exceed the existing Free Record by 1 km. The attached table shows how this proposal would have affected existing World Records, had it been in place at the time each existing record was set.

The wording required to achieve this proposal is:

In Para 1.4.7 add a new sentence at the end of the paragraph.

If a free distance record is claimed for the same flight as a declared distance record, the free distance claimed must exceed the declared distance claimed by at least 5% up to a maximum of 25 kilometres."

*Note that the margin over existing records in 3.1.4a applies to both the free distance record and the declared distance record.*
