Current rule:

ONE - REPLACEMENT OF CHIEF JUDGE.

6.6.1. Chief Judge

The Chief Judge (CJ) for an FCE is nominated by the Judges' Committee from the annual nomination list. This nomination will be made in consultation with the relevant Discipline Committee, who may consult the Organiser. The nomination must be approved by the IPC Plenary. A CJ may only be nominated once per discipline per calendar year. The CJ must have served as an EJ at a minimum of 2 FCE's (1 for CF) or as a CJ at some time prior to the current nomination and must not be from the organising country. The CJ must have a thorough working knowledge of the General Section and Section 5 of the Sporting Code and the Competition Rules, including the latest changes made at the IPC meeting preceding the competition concerned and the philosophy behind these changes. He must also be familiar with all aspects of the conduct and operation of an international competition and will serve as administrative head of the Panel of Judges.

New Rule:

6.6.1. Chief Judge

The Chief Judge (CJ) for an FCE is nominated by the Judges' Committee from the annual nomination list. This nomination will be made in consultation with the relevant Discipline Committee, who may consult the Organiser. The nomination must be approved by the IPC Plenary. A CJ may only be nominated once per discipline per calendar year. In case where the designated Chief Judge is unable to attend the FCE the following procedure will be applied:

1 - The said Chief Judge must inform without delay the Chair of the Judges Committee and the Organizers of the FCE of his inability to attend.

- 2 The Chair of the Judges Committee will immediately inform the IPC Bureau and the relevant discipline Committee Chair of the resignation. The Judges Committee will, within the following 7 days and taking into consideration any suggestion from the relevant Discipline Committee, nominate a replacement Chief Judge.

 3 The IPC Bureau will then take all necessary steps to comply with SC S5 in the
- organization of the FCE.

The Judges Committee propose to the Plenary to complete 6.6.1 for the simple reason that this eventuality did not exist in section 5 before this resignation.

TWO - CHIEF JUDGE HANDBOOK

Current Wording:

Page 3:

1. RESPONSIBILITY of IPC RULES AND REGULATIONS COMMITTEE

The responsibility of the IPC Rules and Regulations Committee is to prepare, maintain and publish the FAI CHIEF JUDGE HANDBOOK.

New redaction:

The responsibility of the IPC Rules and Regulations Committee is to prepare, maintain, and publish in conjunction with the IPC Judges Committee, the FAI CHIEF JUDGE HANDBOOK.

It seems consistant to associate the IPC Judges Committee with the responsabilities of the IPC Rules and Regulations Committee in the preparation, maintenance and publication of the Chief Judge Handbook. That is why we recommand the Plenary to accept this modification.

THREE - CHAPTER 6: FAI JUDGES

6.4: QUALIFICATION TO JUDGE AT FIRST CATEGORIE EVENTS

Current rule:

6.4.1 AL

In the two calendar years preceding the calendar year in which the event is being held;

NEW RULE:

6.4.2. (3) have served as Chief of Judge Training at an official IPC Judges' Training Course approved by the IPC Judge Training Course Coordinator.

It appeared consistent that FAI judges' training course be considered for Chief of Training course as selection in the judging panel. It is mandatory that Chief of training course who agree to do these FAI judges training have a valid qualification. The credibility of our actions depends on it as well as the quality of our training. That is why we recommand the Plenary to accept this modification.

FOUR - CHAPTER 6: FAI JUDGES

JUDGES ATTENDANCE AT FCE 4.6.1

Current rule:

4.6 JUDGES

4.6.1 Attendance at FCEs

(1) There must be a sufficient number of FAI Parachuting Judges available for all appropriate tasks provided in the Sporting Code and Competition Rules.

The minimum number of Fai Parachuting Judges including the CJ, required at an FCE is:

NEW RULE:

4.6.1 Attendance at FCEs

(1) There must be a sufficient number of FAI Parachuting Judges available for all appropriate tasks provided in the Sporting Code and Competition Rules.

The minimum number of Fai Parachuting Judges including the CJ, required at an FCE is:

Freefall Style & Accuracy Landing: 15 Formation Skydiving: 15 Indoor Formation Skydiving: 15 Indoor skydiving Artistic 7 Dynamic: 7

Artist Event: 9 Canopy formation: 7
Paraski: 7 Canopy Piloting: 7

Speed Skydiving: 3 Wing suit: 8

We propose to delete "minimun" because it is difficult to reduce a minimum. In that case what is the interest to set a minimum. But we maintain the opportunity to reduce or increase the number of judges.

Number of judges in Indoor Skydiving and Wing suit in accordance with relevant committees discussions.

FIVE - COMPETITION RULES

Harmonization of a video controller definition.

Current rules :

Competition rules:

NEW DEFINITION:

A video Controller will be appointed and approved by the Scoring system provider as appropriately trained and familiar with the selected scoring system's dubbing process, prior to the start of the Judges' Conference. Before the start of competition, each team must dub a sample video from the team's freefall video equipment into the scoring system for inspection of the resulting video by the Chief Judge, to ensure compatibility and quality setting. The Video

Controller may inspect a team's freefall video equipment to verify that it meets the performance requirements as determined by him/her. Inspections may be made at any time during the competition which does not interfere with a team's performance, as determined by the Event Judge. If any freefall video equipment does not meet the performance requirements as determined by the Video Controller, this equipment will be deemed to be unusable for the

competition.

It was presented and accepted by the late plenary at Faro but not applied.

Current definition :

SEVEN - Section 5 Chapter 4 Organisation of competitions Travel and living expenses

Current rule :

4.1.4 Travel and Living Expenses

(1) The Organiser of an FCE will be required to pay travel, food, living costs and expenses connected with their duties for the following officials, starting no less than a specified number of days prior to the official arrival day for Delegations as per Official Bulletin, unless the competition rules state

otherwise:

- FAI Controller, CP course Technical Director- 2 days, or earlier, at the discretion of the Organiser
- \bullet CJ, Assistant to the CJ,SP scoring Technical Director, Electronic Scoring Operator- 2 days
 - EJ 1 day
- (2) The Organiser of an FCE will also pay food, living and local transport costs in accordance with the current edition of the IPC Expense Reimbursement Policy Document, for the other members of the panel of Judges selected in accordance with
- 4.6.1(2) by the CJ and for the CJT if a Judge Training Course is held at the same time.

The CJT is to arrive on the same day as the CJ.

(3) The IPC will reimburse any Visa cost and the travel expenses of the CJT and each member of the panel of Judges at an FCE, who are FAI Parachuting Judges (not

covered by 4.1.4(1)) included in the selected list, in accordance with the current edition

of the IPC Expense Reimbursement Policy Document.

4.1.4 Travel and Living Expenses

- (1) The Organiser of an FCE will be required to pay travel, food, living costs and expenses connected with their duties for the following officials, starting no less than a specified number of days prior to the official arrival day for Delegations as per Official Bulletin, unless the competition rules state otherwise:
- FAI Controller, CP course Technical Director- 2 days, or earlier, at the discretion of the Organiser

(2) The Organiser of an FCE will also pay food, living and local transport costs in accordance with the current edition of the IPC Expense Reimbursement Policy

The CJT is to arrive on the same day as the CJ.

(3) The IPC will reimburse any Visa cost and the travel expenses of the CJT and each member of the panel of Judges at an FCE, who are FAI Parachuting Judges (not

covered by 4.1.4(1)) included in the selected list, in accordance with the current edition of the IPC Expense Reimbursement Policy Document.

NEW RULE:

4.1.4 Travel and Living Expenses

- (1) The Organiser of an FCE will be required to pay travel, food, living costs and expenses connected with their duties for the following officials, starting no less than a specified number of days prior to the official arrival day for Delegations as per Official Bulletin, unless the competition rules state otherwise:
- FAI Controller, CP course Technical Director- 2 days, or earlier, at the discretion of the Organiser
- \bullet CJ, Assistant to the CJ,SP scoring Technical Director, Electronic Scoring Operator- 2 days
- (2) The Organiser of an FCE will also pay food, living and local transport costs in accordance with the current edition of the IPC Expense Reimbursement Policy Document, for the other members of the panel of Judges selected in accordance with 4.6.1(2) by the CJ and for the CJT if a Judge Training Course is held at the same time.

The CJT is to arrive on the same day as the CJ and the EJ one day later.

(3) The IPC will reimburse any Visa costs and the travel expenses of the CJT and each member of the panel of Judges at an FCE, who are FAI Parachuting Judges (not covered by 4.1.4(1)) included in the selected list, in accordance with the current edition of the IPC Expense Reimbursement Policy Document.

The presence of the JE 1 day before the official arrival date is essential. The JE, unavoidable judge must verify the proper functioning of all that concerns the judgment of the event which he has in charge especially with the teams present. The CJ being busy with the good running of the events in all the aspects will not have objectively no time to check everything including the plan of the materials of judgment and the organization of assignments of judgment.

EIGHT: Section 5 chapter 6.1.2 (4),(5),(6),(7),(8)

Criteria for judge training and evaluation.

Current rule:

- (4) Written Evaluation of the Sporting Code and the Competition Rules
 The written evaluation is an open book examination. It consists of:
 - One examination of the contents of the Sporting Code; and
 - One examination of the contents of the relevant Competition rules.

The candidate shall be given a maximum time of two (2) hours in which to complete both examinations, under the supervision of the CJT. In order to achieve a passing grade, at least 90% of the questions on each examination must be answered correctly.

- (5) Evaluation in ST, FS, CF, AE, IAE and WS(A)
- (6) Evaluation in AL, CP, SP and WS(P)
- (7) Final Qualification as an FAI rated judge.

Necessity to clarify (4) and house keeping.

NINE: Section 5 Chapter 6.6.6.

6.6.6 Replacements

(1) Failure to respond

If a Judge who has been selected to the Panel of Judges fails to respond within 14 days to the CJ's notification that he/she has been selected, or fails to provide his/her logbook for examination by the CJ, if requested by the CJ at any time after the time of selection, that Judge will be considered to be unavailable and the CJ will then select another available Judge and will inform the Organiser and the relevant NAC's of this replacement.

(2) Inability to attend

If a Judge has accepted his selection to the Panel of Judges and is unable to attend, he must immediately notify the CJ who will then select another available Judge. If the Judge does not so notify the CJ, that Judge will be found unacceptable and 6.6.7 will apply.

(3) Absence

If Judges from the selected Panel are not present at the required time or an insufficient number of Judges are present; the CJ may choose replacements from any FAI Parachuting Judges present. The Jury must approve such replacements.

New rule:

6.6.6 Replacements

(1) Failure to respond

If a Judge who has been selected to the Panel of Judges fails to respond within 14 days to the CJ's notification that he/she has been selected, or fails to provide his/her logbook for examination by the CJ, if requested by the CJ at any time after the time of selection, that Judge will be considered to be unavailable and the CJ will then select another available Judge and will inform the Organiser and the relevant NAC's of this replacement.

(2) Inability to attend

If a Judge has accepted his selection to the Panel of Judges and is unable to attend, he must immediately notify the CJ who will then select another available Judge. If the Judge does not so notify the CJ, that Judge will be found unacceptable and 6.6.7 will apply.

(3) Absence / Insufficient proposed Judges

If Judges from the selected Panel are not present at the required time or an insufficient number of Judges are present; the CJ may choose replacements from any FAI Parachuting Judges present, or from the current nominated FAI judges list. The Jury must approve such replacements.
