The system, collecting videos of each team to determine the difficulty factor 48 hours before the start of the competition has proven itself well. This also speeded up the judging procedure. Participating Teams: Freestyle: 12; Freefly: 11 - the injury of a performer from the Italian Freefly Team was the reason for the failure of this team from the third round.
