Details of the Judges Work: (including judging statistics)	Björn Korth replaced Exi Rainer Hoenle as CJ, Zurika Bleeker replaced Björn Korth as Panel Judge. That causes the Organizer Judges beeing short of one judge. Two additional judges were accepted by the CJ. This replacements were caused by the required replacement of the FAI controller on short notice. In total 797 jumps were judged in classic events and 121 jumps in CP Freestyle.
Recommendations for Organisers:	Appoint Course director in time and practice course set-up and changes before the competition starts, so course change could be done fast, if needed. Practice full course set-up and check with rules. ZA setup for headwind. If ZA mostly downwind, consider adding a 2nd ZA landing area on the other side of the pond.

Rule Changes - Proposals:	Freestyle: More detailed describtion of the moves. Declaration of drama sheets at least 36h before the start of the competition. Create list of judged DOD of combinations and publish (like 12h before start of competition) for feedback. Distance course specification for DZ above 1000m MSL. Speed course setup: Specify tolerance for "evenly distributed".
Personal Remarks:	The judges conference should have at least one night for consideration, changes and verification the next day. Best would be training in each disciplines for judges and competitors, however practically not possible everytime.
