Competition:	FAI WORLD CUP AND EUROPEAN CHAMPIONSHIPS 2017
Event:	14 th FAI EUROPEAN Formation Skydiving Championships 2017 21 st FAI WORLD CUP of Formation Skydiving
Place:	Saarlouis - Dueren, Germany

Details of the Judges Work: <i>(including judging statistics)</i>	Panels judged: 212 FS4 jumps, 28 FS8 jumps, 38 VFS jumps. The Panels worked very well as a team, with good team spirit thorough out the competition. The scoring system worked very well too.
Recommendations for Organisers:	The Organizer did a very good job, technical staff were available all the time, the Chief judge assistant was very helpful. Very well organized transport of FS / VFS judges to and from the airfield Recommendations: The competition should be configured in advance in the system, with the correct competition name and dive pool. File transfer to official IPC results website should also be prepared in advance together with system vendor and IPC press officer. Internet access on the drop zone should be much better. System vendor should have a representative on competition site, a person who understand both technical part of system and understand skydiving disciplines
Rule Changes Proposals:	1. The number of judges at a World Cup competition should be as great as the number of judges at a World Championship, there are many teams competing under the World Cup, even more than at a WPC. 2. Videographer should have backup camera as mandatory, in purpose to avoid re-jumps and it can save a lot of time 3. CR 3.2.2.1, part ii. need clarification: after wording: "the last common scoring formation" add wording "(Whether it's bust or point). Also complete the rule with "for judging purpose speed based events in system should be used) 4. GS S5, 4.6.1 (2) Reduction of number of judges due to few registered teams should be considered only after final registration
