PROPOSED RULE CHANGE FROM THE IPC PRESIDENT SPORTING CODE SECTION 5 - CHAPTER 3 - RECORDS

Explanation

The General Section only refers to performance records and does not specifically refer to competition records. It does allow ASCs to define their own Absolute Records (7.2.). IPC has defined two separate categories of record, **competition (G1)** and **performance (G2)**.

S.C.G.S. 7.6. defines that **«** On any date that a record is broken by more than one claimant, the best performance only will be awarded the new record except if an Air Sport Commission has a special provision for such a situation which is described in its own section of the Sporting Code".

It is therefore necessary to clarify clearly in Section 5 that each competition round is considered separately regardless of the day on which it takes place. i.e. a competition round may go over more than one day but only the best performance of that round will be considered, and there may be several best performances in the same day because they are performed in separate rounds.

3.2. COMPETITION RECORDS

3.2.1. Competition Records may only be established during the scheduled competition rounds at an International Sporting Event, which has been registered in the FAI Sporting Calendar, or at a National Championships. which is not open to participation by NACs other than the organising NAC. For the purposes of this provision, unless a specific invitation is issued by the organising NAC to another NAC, teams or competitors from a country other than the organising NAC and permitted to participate in a National Championships are considered to represent the organising NAC.

3.2.1 Training Jumps / Tie-break Jumps

3.2.1.1. Training jumps as defined in the Competition Rules are not to be considered as scheduled competition jumps.

3.2.1.2. Tie-break jumps as defined in the Competition Rules are considered to be scheduled competition jumps, except where the record is set in a competition program (3.2.2, 3.2.5.2, 3.2.7 and 3.2.9)

3.2.1. Performance

Only the best performance of each separate scheduled competition round will be awarded the new record, regardless of the day on which it is performed.

- 3.2.1.1. Training jumps as defined in the Competition Rules are not to be considered as scheduled competition rounds.
- 3.2.1.2. Tie-break jumps as defined in the Competition Rules are to be considered to be scheduled competition rounds, except where the record is set in a competition program (3.2.2, 3.2.5.2, 3.2.7 and 3.2.9)
- 3.2.2. Simultaneous Records in FS, VFS, IFS, IVFS, CF, CP, SP, WS and IAE Dynamic
 If two or more competitors or teams achieve the same record performance during the same competition round, the new record shall be registered in the names of all the competitors or teams involved.

3.2.2. Event Entry Criteria

Event Entry Criteria is according to the Sporting Code General Section with the exception of 4.5.3.2. which does not apply, and, for the purpose of this provision, unless a specific invitation is issued by the organising NAC to another NAC, teams or competitors from a country other than the NAC and permitted to participate in a National Championships are considered to represent the organising NAC.

3.2.12 Joint Record holders in FS, VFS, IFS, IVFS, CF, CP, SP, WS and IAE Dynamic (1) If two or more competitors or teams achieve the same record performance during the same round and thereby break an existing record, the new record shall be registered in the names of all the competitors or teams involved.

(2) If a competitor or team achieves a performance during a later round in the same event, which is equal to a new record performance achieved during an earlier round in that event, no recognition will be given to the performance in the later round as being a record performance.
