WORLD AIR GAMES. An International Sporting Event involving several FAI air sports at the same time and open to participants from NACs. Rules for the WAG are available from FAI. CASI will approve General Rules for the WAG. For the **2009** WAG, where these General Rules are in conflict with the Sporting Code, the General Rules will prevail.

6.8.4

Each ASC may include provisions in its Specialised Section that will allow notification directly to FAI of a record performance set during a First Category Event. Such a notification will not be required to follow the provisions of 6.8.1, 6.8.2 and 6.8.3. However the notification sent directly to FAI must also be sent to the record claimants NAC, so that the requisite administration fee may be paid.

8.1.3

<u>ISSUE OF SPORTING LICENCES</u>. Each NAC has the delegated power to issue FAI Sporting Licences on proof of identity to those of its individual members who are either citizens or residents of that NAC's country. If a NAC does not pay the required annual subscription fees before the due date of March 31, any Sporting Licenses issued by that NAC are suspended as of that date and that NAC may issue no more Sporting Licenses until the required annual subscription fees have been paid. The Sporting Licence database will be updated accordingly by the FAI Secretariat immediately after March 31<sup>st</sup> and again without delay at the time payment is received.

A Sporting Licence shall only be considered issued and valid, if the holder is listed on the FAI Sporting Licence database by the NAC that is issuing the particular Sporting License.

The information in the database must include, but is not limited to, the name of the issuing NAC, the name of the holder, a number given by the NAC and the date of expiry.

A Sporting License may be issued for one airsport discipline (see 1.2 above) or for multiple airsport disciplines. This information must be clearly indicated in the Sporting License database.

8.1.4; 8.1.5 and 8.1.7 as these deal with a Sporting License Form, which is no longer required with the new 8.1.3.

8.1.3.6.4

<u>Change of Representation - First Category Events</u>. If a person has represented a country in a First Category Event, that person must not represent another country in any First Category Event during the twenty four months following the month in which the First Category Event, in which the person represented the first country, takes place. **entire two calendar years (January 1 to December 31) following the calendar year in which the person represented the preceding country)** 

Also, see 8.1.3.2, which prevents the holding of two Sporting Licences at the same time. In the exceptional circumstance where, due to geopolitical change and not personal choice, a person becomes resident of another country and is no longer eligible to hold a Sporting Licence in the prior country, this time period can be reduced on the condition that the NACs concerned give their written approval and the case is reviewed and approved by the CASI Bureau.
