### Discussion Points for 2018:

- 1) There are discussion points in 2016 Annex 54 to address for 2018. This includes the issue of recording music to those video files for performers who are flying with music. Please see 2016 Annex 54.
- 2) Scoring systems should ingest videos for the preliminary difficulty round for freeflying, freestyle skydiving and indoor solo freestyle skydiving (AE CR 5.2.3 and SFR CR 5.2.1). This will allow judges to view the videos with freeze frame at the end of working time and more reliable archive of this preliminary round.
- 3) Dynamic scoring systems should ingest all video angles (centreline, sideline, ring) for the speed routines (Dynamic CR 4.2.8.1). This is important for the judges to do video review whenever a team challenges a bust (Dynamic CR 6.3.8), and for archive of the videos. SkyVenture Montreal's video system was very well designed and performed to the task, but many wind tunnels may not have such a sophisticated system.
- 4) At the 2017 WC of Wingsuit Flying, there was an inquiry about posting GPS data log files (.csv) to the internet to permit competitors to download and view them. (For WS Performance, these are the "video" equivalent to AE, FS, etc.)
- 5) Freestyle Canopy Piloting CR 8.1.1 requires video recording to pan with the competitor over the water to landing, with a slate. The scoring system should facilitate archiving these videos. There is no freestyle canopy piloting, yet, in the IPC Judge Video Library.

6) Acceptable File Formats should be discussed and agreed upon...this is a discussion related to functionality of scoring systems with that video format. For the 2017 EC WC, the video files were .mkv files. For the 2017 WISC and 2017 WC of Wingsuit Flying, the video files are .mp4 files. At the WC of Wingsuit Flying (November), it was expressed that .mp4 is a better video format.

Competition videos, data and pertinent documents are essential for developing judge skills as well as for competitors and future competitors to develop their skills. These materials are "reliably" available through the IPC Judge Video Library. And we want to preserve history.
