6 Future of championships – general discussions

6.1 General Section definition of a Microlight

In the FAI General Section under 2.1.1.16 there is a definition of Microlight as follows: A one or two seat aeroplane with a specific maximum mass and characterised by a very low wing Loading. It used to be a maximum weight or 25 kg/m2 wing loading.

This is no longer correct. It is better to talk about maximum weight/mass and minimum stall speed. CASI, the relevant rules commission, have requested CIMA for an update.

6.2 Format of final competition results

The format of final results of competition various from event to event (not only in CIMA events). To make it easy to read, to store in archives and for publication purpose we need to have a clear description. CIMA president has requested guidance on this from FAI Sec. Gen. Plenary to discuss, and implement this in our guidelines/annex for competition bids, organizer guidelines and jury handbook.

6.3 Championship bidding process

CIMA bidding process needs updating to include more details in the document and a description of the process we have to follow in CIMA, who is taking care about the details of the organiser agreement like signing, setting the dates for paying the deposit etc.

6.4 FAI database of approved officials, and jury guidelines

There is a request from FAI to have a data base for approved officials. CIMA wiki contains a list but this is not well maintained. In case of an appeal, if it is found that some mistakes had ben made by the jury, it would be advisable to be able to demonstrate training or at least better instructions. CIMA need to make a revision of our jury guidelines. Some commissions have a detailed list of issues to be checked by the jury to ensure a successful event. CIMA President is researching the practices of other commissions.
