## **10. CIAM Treasurer's Report** (Issue 1)

- 10.1 CIAM 2016 Budget
  - The attached table contains the budget and final statement for 2016, the last year approved budget for 2017 and the draft budget for 2018, with additional remarks concerning the specialities of CIAM.

The costs of CIAM officers appear in different items depending on the different meetings. It is still problem to insert such expenses like the CIAM scholarship, trophy repair costs and others, which now appear as exceptional costs.

• The detailed final CIAM 2016 budget statement shows the following balance data as of the still provisional statement dated Apr. 18, 2017:

Special Reserve	on Jan. 01, 2016:	EUR 49 634	(Opening balance)
Net result	on Dec. 31, 2016:	EUR 5721	(Net movement)
Special Reserve	on Dec. 31, 2016:	EUR 55 355	(Closing balance).
Liabilities net	on Dec. 31, 2016:	EUR -3 547	

The origin of liabilities are connected to bid fees, sanction fees and other accrued expenses.

The net movement turned from the budgeted zero to EUR + 5 722.

As it is usual, some budgeted costs are not yet spent and some not budgeted items appear in 2017.

The bank charges are still not covered in some cases by the originators.

See also the attached graph for the basic budget details from 2001 to 2016.

Sanction fees

The payment situation is quite the same as usual. The majority of the sanction fees arrived in time, some were again late or not fully paid, or information was missing.

• Payments for medals

The medal payment status for 2016 is not better than in some previous years. Two medal payments are not yet paid by Poland (CHF 1322) and Serbia (CHF 1983), urging of these payments are in progress. In several cases the invoices were not paid within the 30 days payment deadline, but at least by the end of the year.

• Sponsorship

The two times EUR 2000 sponsoring money by ERSA is not yet paid.

10.2 CIAM 2017 Budget

There are not much movement yet in the 2017 budget, late sanction fees arrived and refunds happened for the president's travels and other cases.

10.3 CIAM 2018 Budget Proposal

The proposed draft 2018 budget is shown in the last column of the attached table. The budgeted net movement now the third time is planned to be zero (after several years of negative movements).

10.4 CIAM Scholarship

After two years of delayed payment now the sixth edition of the CIAM scholarship is paid in the actual year.

10.5 Model stickers usage

The stock of model stickers is expected to cover the need for 2017-2018, so the next order is due in early 2019, earlier than expected, as the need in 2016 was 6710, over the average of about 5000/year.

10.6 Handling of the sanction fees of cancelled events

The Bureau was in agreement not to keep these fees for further years. These fees are not refundable if not used in the relevant year for the same event at another date.


