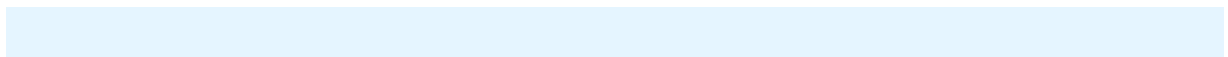

### Championship classes

These 7<sup>th</sup> **FAI Women World Gliding Championships 2013** will be held in following classes as described in the main body of Section 3 of the FAI Sporting Code (Chapter 6.5 in October 2011 Edition) :

- Club class
- Standard class
- 15m class

### National Teams

Each NAC may enter **up to 3 pilots** and 1 substitute/reserve pilot to each class. Reserve pilot will normally only replace a nominated pilot in the event of a withdrawal. The present World Champions are automatically qualified and will be admitted in addition to the above quota. They must, however, be entered by the NAC.

### Total number of allowable entries

The maximum number of gliders in any class is 40 and the total number of allowable entries shall not exceed 120.

### Pilots requirements

The requirements to pilots will be as defined by the Sporting Code, Annex A to Section 3 Part 3 with no modifications.

### Entry fee and Payment instructions

The entry fee for each competing glider is 750 €. This covers all operational costs during the Championships except aero tows.

The full payment (net sum of € 750) shall be received on the bank account below by 31<sup>th</sup> March 2012. The competitor must cover all bank fees. Please ensure that bank transfer documentation includes identification of the entrants for. Payment by cheque is not possible.

### Aero-tows

Aero-tow fee is 40 € (500m QFE).

The organiser will require paying for 10 aero-tows in advance to staff at the contest site. This payment, together with all camping and accommodation fees (if applicable), have to be done at the latest before the start of first training flight.

Aero-tow fees if unused will be refunded in full.

### Gliders rental

The Aeroclub Issoudun offers some gliders for rent.

### Accommodation

### Rules

The FAI Sporting Code General Section 3 with its Annexes will apply.

The Local Procedures will be issued with the bulletin n°2, after approval by IGC and will be published on the competition website.

Flight documentation will be by IGC approved GNSS FR only.

All flight recorders which have received IGC approval for championships by 31 march 2012 will be admitted.

A valid GNSS FR calibration for primary and secondary FRs will be required before the first competition day.

### Insurance

The glider shall be covered by third party insurance - **not excluding competitions** – in conformance with EU Regulation 785/2004 which states (art. 7) the coverage should be expressed in SDR (Special Drawing Rights) with the following limits applying :

| - Certified MTOM < 500 kg | Minimum insurance(SDRs)  | 750 000   |
| - Certified MTOM < 1000kg | Minimum insurance (SDRs) | 1 500 000 |

Personal medical insurance is required for all team members, covering accidents and sickness, including hospital costs and transport back to the team member's country of residence.

Documentary proof of all insurances shall be made available to the organisers in French or English at check-in, in the form of original documents or copies.

Required insurance will be available for purchase at the contest site.

### Internet Access at the airfield

Internet will be available at the camping, restaurant and near the office through wireless LAN (WLAN, IEE 802.11g).

Internet will also be available at PCs in the bar.

### Mobile Telephones

There are many mobile operators in France but mainly three separate GSM networks. Two of them have a best coverage in the competition area : Orange and SFR.

Phones and SIM cards with prepaid communication time will be available for purchase at reasonable cost on site.

**Team captains must have a mobile phone with French SIM card.**

### **PC for downloading of GNSS FR records**

The organisation will make available a number of PC for downloading flight log from the GNSS FR. Competitor must bring their own cable to connect FR to PC.

Flight logs will be send to scoring by email (email address will be given in Local Procedures).
