Additional information to Bulletin nr. 1:

1. Entry fees & Registration:

Entry fees:

1. Competitor one event: **820 Euro** (including FAI Sanction fee 110 Euro).
2. Competitor two events: **1 000 Euro**
3. *Competitor Team-Alternate(reserve)*: **570 Euro** (including FAI Sanction fee 110 Euro).
4. Officials: **570 Euro** (including FAI Sanction fee 110 Euro).
5. Accompanying persons: **450 Euro.**

Entry fees cover:

For all competitors: competition jumps, re-jumps and tie break jumps; FAI sanction fee, five times hotel accommodation in 3 – 4 stars Hotel rooms with double occupancy, including five times breakfast, five times lunch, five times dinner including Farewell banquet.

Competition jumps are treated as number of jumps per team so in “competitor Team – alternate (reserve)” - entry fee the competition jumps are not included.

For all officials: FAI sanction fee, five times hotel accommodation in 3 – 4 stars Hotel rooms with double occupancy, including five times breakfast, five times lunch, five times dinner including Farewell banquet.

Transportation is available for all and is included in entry fees. Transport from Otopeni Airport to the hotel / DZ on arriving day, and back to the airport on departure day if is booked prior June 21st.

Local transport hotel-DZ-hotel is available for all and is included in entry fees.

Every delegation must fill and send the document regarding room sharing attached to this Bulletin.

Note! Single bed rooms upon request and availability will cost an additional fee of 30 euro /person /night.

2. Cancelation of 4-Way Sequential discipline :

Despite the efforts if the IPC Bureau and the Canopy Formation Committee to encourage more teams for participation in the CF Event, only 3 NACs registered in 4-Way Sequential discipline.

Therefore 4-Way Sequential discipline is CANCELED and will not take place at the European Championships and World Cup in Strejnic, Romania 2019.

Registered 4-way sequential teams, will be able to jump, their performances will be judged, without issue of title or medals.

3. Registration procedure:

The Final Registration Form and Documents must be submitted to the Organizing Committee before **June 21st, 2019** to info@epc2019.ro /cc: detasamentparasutism@aeroclubulromaniei.ro.

The room sharing plan and arrival details must be submitted to the organizing Committee before **June 21st, 2019** to info@epc2019.ro /cc: detasamentparasutism@aeroclubulromaniei.ro.

For registration please use the files available for download from <https://www.epc2019.ro/documents/> and send them to us in the same format (Excel).

Please note that each attending competitor must complete 3 additional documents. You can find these documents on <https://www.epc2019.ro/documents/>

All 3 additional documents can be completed and signed at Strejnic dropzone too on arrival, but be aware that competitors must have original parachute documents and skydiving license with them.

The Statement of honor as regards to the health condition (applicable to owners of licenses issued by other States) will be completed only for the competitor that **DO NOT HAVE** medical class 2 ICAO.

These official documents are written in both Romanian and English and they are part of the Romanian Regulations.

4. Payment details:

Payment must be made in EURO by Wire transfer / bank transfer to the following bank account.

Payment and Official final entry form must reach the organizer before **June 21st, 2019**.

Cash payment of entry fees on arrival is only possible with prior announcement and by agreement with the organizer !

5. Accommodation for training period:

During the training period, it is possible to find accommodation in town for 40€/room/day. There is also variously priced accommodation available in the vicinity of the DZ (pensions, hotels, guest houses, private accommodation).

6. Competitors requirements:

A valid FAI Sporting License for 2019 is required and must be obtained through the Competitor's NAC.

All competitors must be registered by their NAC – before submitting the Official Entry Form to the Organiser – in the FAI Sporting License Database <http://www.fai.org/about-fai/fai-sporting-licences>

Please all delegation members provide us a face picture (for badges) to info@epc2019.ro /cc: detasamentparasutism@aeroclubulromaniei.ro. not later than **June 21st, 2019**. This will help the organiser by supplying the badges on time.

7. Equipment requirements:

It is the responsibility of the competitor that the parachuting equipment to be used is certified as being airworthy by competent authorities. The Organizer has no responsibility in this regard; the responsibility rests fully with the Delegation and competitors. The Organizer validates only the airworthiness documents for the equipment. Competitors must complete an application for parachute documents validation and you can find this as an attachment to this bulletin.

Due to Romanian Civil Regulations reserve parachutes must be packed within the last **180 days**.
