<b>Rule Changes - Proposals:</b>	<p>fs_vfs_competition rules</p> <p>Rule # 5.4</p> <p>The Chief Judge will decide prior to the start of the Competition the percentage of reduced speed to be used for the different Events.</p> <p>The Chief Judge will decide, at the latest, after the first jump of each round the percentage of the reduced speed to be used for the whole round. (something like that.. )</p> <p>the reason is, that we have slow rounds and very fast rounds... it is not suitable to pick ONE Slowmo Speed for the whole event... CJ should be able to pick the speed for each round</p>
