### Comments:

Both complaints were submitted verbally

The first complaint had to do with the placing of the camera for Formation Skydiving. Article 4.7.3. of the competition rules state that no re-performance can be requested when the team flies to high and out of sight of the camera.

- After talking to the team, they decided to withdraw the protest
- We advised them how to submit a possible rule change

The second complaint was based on a procedural mistake and was granted.

No protest fee remains after these results
