Comments:

Doping control took place on October 27th. The FAI order for testing was the top 5 of the events FS4 open, D2W, SFR.

Normally doping control takes place at the end of the day / competition. The doping controller was under the impression that this day October 27th was the last competition day, which it was not, that was October 28th. Testing was scheduled for one day only, so there was no possibility to move the testing day. Therefor the testing had to be done not based on final standing, but on standings to be defined. After discussion, day results were deemed acceptable and not in violation of any known requirement.

The particularities of judging in parachuting and indoor skydiving is that results are not known immediately. So to the define the top 5 ranking on the day itself was deemed impossible, at least for the indoor AE events in the afternoon.

Taking all this into consideration, the day results of October 26th were used to define the top 5 ranking for the controls on the 27th.

The Jury recommends the following to FAI:

- 1. To make sure that any doping control office understands what is the final competition day for an event, and if the control needs to take place at the final day, yes or no.
- 2. To clarify to all airsports how and when to define the rankings to be used for doping controls.
