PROPOSAL FOR CHANGES TO THE SPORTING CODE SECTION 5 FROM THE ISC BUREAU

3.1.2.4.

(5) The claim for certification of an International Record must be made in accordance with Chapter 7 of the GS. The Jury will manage the administration of the record claims as laid out below. In all cases, the responsibility will lie with the record beneficiary to ensure that the record is claimed (GS 5.5.4.). The following procedure is designed to facilitate the claim process, but ISC cannot be held responsible for errors or omissions.

The claim for certification of an International Record must be made in accordance with Chapter 7 of the GS.

- (a) Where a World Record performance, whether it is a Competition Record or a Performance Record takes place during an FCE, GS. 7.8.4 will apply using the following procedure:
 - The claim for the record performance will be sent electronically directly to FAI by the Jury
 President and may include a Continental record that results from the same performance
 on the same record claim.
 - The claim must include all information necessary to properly categorise the record claimed (as per GS 7.8.2), including a copy of the official result for the jump/performance in which the record performance occurred.
 - A copy of the claim will be made available to the record claimant's NAC.
 - A continental record performance resulting from the World Record will be included on the record claim.
 - ISC will pay the FAI expenses related to all World Competition and World Performance records that take place at an FCE
 - ISC will pay the FAI expenses for combined World and Continental Competition and Performance Records that take place during an FCE except in the case of multiple World Records by the same competitor, where ISC will only pay for the best one of the Continental records achieved.

In multi-discipline competitions where there is a high number of records, it is easy to miss a continental record especially those that are way down in the results lists. The service that we provide is just that, a service, and we should not be held responsible in any way. When discussing the record issue with competitors and record holders, their main argument is that records help them get sponsors. This is a personal benefit and nothing to do with ISC or FAI. Whereas World Records can draw attention to the sport if used wisely, they mostly do not. When there are multiple world records in a competition for the same event, we need to determine if we recognise them all. If we do, then I propose, after discussion with the Finance Secretary and the Bureau, that we only pay for the best continental record of the competition.

FAI Skydiving Judges additional to this number, must be agreed to by the CJ and the Organiser and must have been included in the nomination list (see 6.5) for that WPC/WISC. The Organiser must supply sufficient personnel to act as judging assistants as required by the competition rules. assist the CJ in filling the technical and administrative positions.

(5) The Organiser, in consultation with the CJ, may appoint Judging Assistants from among any additional FAI Skydiving Judges or FAI Member National Judges present at the competition site.

If the number of judges necessary for a competition is correct, then there is no need to add judges on site. The paragraphs have been queried before and an addition was made to limit abuse (inclusion in the nomination list) but they are not necessary if our judge nominations are carried out correctly.
