Rule Changes - Proposals:	Competition rules FS & VFS 4.5.2. says that "All video equipment must deliver a High Definition 1080 type digital signal with a minimum frame rate of 50 frames per second, through a memory card. The videographer is responsible for ensuring the compatibility of the freefall video equipment with the scoring system. " If the videographer will bring incorect video format then the team's score will automaticly be 0. This is a very inadequate punishment. My suggestion is: For the first time, a yellow card is given for an incorrect video format; the second and subsequent time, 1 or 2 points deducted from the result of the match.
