<b>Rule Changes - Proposals:</b>	<p>Competition rules FS &amp; VFS 4.5.2. says that "...All video equipment must deliver a High Definition 1080 type digital signal with a minimum frame rate of 50 frames per second, through a memory card. The videographer is responsible for ensuring the compatibility of the freefall video equipment with the scoring system. "</p> <p>If the videographer will bring incorrect video format then the team's score will automatically be 0 . This is a very inadequate punishment.</p> <p>My suggestion is: For the first time, a yellow card is given for an incorrect video format; the second and subsequent time, 1 or 2 points deducted from the result of the match.</p>
<b>Personal Remarks:</b>	<p>The Assistant to the CJ's, Nina Engel, did a fantastic job ensuring the judges were well cared for.</p>
