CHIEF JUDGE'S STANDARD REPORT

Competition:	 4th FAI World Championship of Indoor Skydiving 2023,
Event:	ISF Open and Junior
Place:	Hurricane Factory Tatralandia s.r.o., Brezovec 1090, 031 05 Liptovský Mikuláš 5, Slovakia.

Details of the Judges Work: <i>(including judging statistics)</i>	<p>All judges were present in time and despite time difference ready to work.</p> <p>InTime-scoring system: After an update the system works well. The whole of Monday was used as a travel day for the judges. Therefore, the remaining 1.5 days were very short to determine the difficulty factor of the free routines. Wednesday afternoon was available for the teams to present their free routine to the judges.</p> <p>The 6 judges did a very focused job and were ready on time. Three ZOOM Meetings before the competition to go through the Compulsory rounds, Execution determination and Technical Table , letting us start with a well prepared panel.</p> <p>Participating Teams: ISF Open: 20; ISF Junior: 10 Both events were completed with 5 rounds. No Reflight, complaint or protest.</p> <p>30 Technical Videos were judged. 150 Flights were judged live. The free rounds were judged by the same panels, in the compulsory one judge from one panel swapped places with one from the other panel so that everyone judged the same number of compulsory rounds. These are viewed again from the video according to rules.</p>

Recommendations for Organisers:	<p>After we found a silent room downstairs in the Tunnel, with big windows to the Zoo, everything was perfect organized for the ISF panel on Monday.</p> <p>Judging Room, accommodation in walking distance, food and coffee the whole day was more than standard.</p> <p>Big thanks also to the FAI Controller Ron Miasnikov for handle every problem immediately.</p> <p>The whole crew of the tunnel did their best to solve a problem as fast as possible.</p>
Rule Changes Proposals:	<p>After competition was finished, a competitor meeting for the upcoming rule changes was organized by Ron Miasnikov and me. Nearly all the teams joined it.</p>
Personal remarks:	<p>Providing a standby panel has proven to be emotionally difficult for me. All 3 judges had to be available until it was clear that there were enough registrations. Whatever all 3 judges were willing to do so.</p> <p>I'm not sure if the travel expenses have increased as a result.</p>
